



## **Executive Program “Artificial Intelligence and Cybersecurity in Global Digital Age: Policy and Management Solutions”**

Following the support of the Med-Or Foundation, Luiss School of Government is offering **20 full scholarships** for participation in the Executive Program “Artificial Intelligence and Cybersecurity in Global Digital Age: Policy and Management Solutions”, to be held in Rome, Italy.

The scholarship covers:

- Full tuition Fee
- Teaching Material
- Pre-paid return economy flight from your country of residence
- Transfers to and from Rome airport
- Full accommodation between 23 October-29 October 2022
- Meals related to the academic program

These scholarships are exclusively reserved for candidates who satisfy all the following criteria:

- Nationality and residency primarily in one of the following countries: Turkey, Lebanon, Jordan, Israel, Egypt, Tunisia, Algeria, Kuwait, Saudi Arabia, Oman, Qatar, United Arab Emirates, Bahrain
- Holder of at least an undergraduate degree when submitting the application;
- Under the age of 40 when submitting the application;
- Knowledge of English with a minimum level of B2;
- Strong professional motivation for attending this Executive Course

### **Procedures for the Assignment of the Scholarships**



Scholarships will be awarded by a Committee appointed by the Executive Course Director (or his / her delegate) and 1 member of the Med-Or Foundation (or his / her delegate).

The process will consist of two phases:

- preselection
- interview.

The Committee will undertake a pre-selection based on the application documents submitted during the application phase:

- Motivation Letter describing the professional motivations for attending the course: up to 10 points
- Curriculum studiorum: up to 10 points
- Professional curriculum: up to 20 points
- Language skills: up to 5 points.

All documentation must be uploaded to the [portal](#) by **10 September, 2022**.

The Committee will identify a list of suitable candidates to be called for an interview. Only candidates who have obtained a score equal to or greater than 45 points in the pre-selection phase will be admitted to the interview.

Pre-selected candidates will be informed about the interview via a message to the e-mail address indicated on the application document. Luiss Guido Carli declines any responsibility for the correct receipt of the communication to the candidate's e-mail address.

Interviews are provisionally scheduled for **15 September, 2022**. The Committee has the right to bring forward or postpone the date and timing of the scheduled interviews by informing the candidates in advance exclusively by email. Also in this case, Luiss Guido Carli declines all responsibility for the correct receipt of the communication to the candidate's e-mail address.

Interviews will be held entirely online through one of the commonly used digital platforms, including Skype, MS Teams or Cisco Webex. It is the candidate's sole responsibility to equip himself/herself with the necessary technological tools for the online interviews.



Failure to participate (for any reason) in the online interview will result in immediate withdrawal from the entire selection procedure.

Upon completion of the interviews, the Committee will determine the final ranking of those eligible to receive full and partial scholarships. The ranking will take into consideration the following criteria:

- Motivation Letter describing the professional motivations for attending the course: up to 10 points
- Curriculum studiorum: up to 10 points
- Professional curriculum: up to 20 points
- Language skills: up to 5 points.
- Interview: up to 55 points

Selected candidates will need to formally accept the scholarship by forwarding to Luiss School of Government the mandatory documentation by the deadline provided.

Should one or more of the selected candidates refuse a scholarship, these will be awarded to the next suitable applicant in the ranking.

#### **Duties of the Assignees of Exemptions**

Scholarship awardees are required to behave in accordance with the highest levels of academic standards and personal integrity. Attendance of all academic activities for this Executive Course is compulsory. Absence will not be permitted for professional or personal reasons.

#### **Processing of Personal Data**
